SUCCESS STORY

FCC ECFS

The Federal Communications Commission (FCC) Electronic Comment Filing System (ECFS) allows the public to participate in shaping telecommunication and broadcast rules, such as net neutrality. The previous version of ECFS crashed during high traffic periods. TCG collaborated with the FCC to develop a cloud-first, scalable architecture using AWS's Elastic Container Service (ECS) to handle surges in demand and ensure data security. This architecture reduces single points of failure and saves costs by adjusting computing power as needed.



In July 2022, ECFS was tested when Dish Network proposed using the 12GHz radio spectrum for a 5G network, prompting SpaceX to urge Starlink users to protest the initiative. As a result, ECFS received 95,000 comments within a week from petition signatures. Despite the traffic increase, ECFS's response time remained stable, demonstrating the system's scalability and reliability.
